The district has identified certain needs that will be funded by the CRRSA-ESSER II grant that will provide a continuation of services for students impacted by the COVID-19 pandemic. We will provide therapeutic care for identified students who have experienced isolation, trauma, depression and anxiety. This therapeutic care will include individual and family counseling to support students' academic success and mental health needs. The district is also planning to improve elementary science and STEM, English Language Arts and Visual and Performing Arts through learning academies throughout the year. An analysis of student growth will be used to determine areas in need of support to increase student success, with the goals of increased fidelity to the standards and the inclusion of performance-based learning and thematic structures that accelerate, rather than remediate, learning. Social-emotional learning will also be a key factor in student success.
